Creating a robust well-designed MCQ requires careful preparation. Attend an assessment design session with the T&L Office learning technology team to learn about MCQ design set-up and considerations – follow this link

Always have a variety of question types.

Always 'test your quiz/assessment' in advance of the exam. Enrol a colleague as a student and run a test and ensure the instructions are clear and the test runs as planned. This is critical.

**Deferred feedback** is generally the preferred option to use for summative MCQ's/online assessment quizzes. **This allows the lecturer to review the marks before the student receives them.** 

Online quiz assessments should be a combination of 'short answer' **and** 'essay' type questions to allow learners to apply knowledge, reflective statements and distinguish themselves.

Weight your questions in the Quiz: careful consideration should be given to the marking scheme. For example, short answers (lower weighting) and essay/reflective statements (higher weighting).

If you are using a time limit or closing the quiz at a certain time, be sure to set 'When time expires' to 'Open attempts are submitted automatically'. This will save whatever the learner has answered so far and will prevent lost work.

Make quizzes as **unique as possible** for each learner by inserting **random** questions from a question bank category and using 'short answer' and 'calculated' questions where variables are generated randomly.

There is an option to prevent **Backward navigation (on Moodle quizzes).** If you are using this feature, make sure students are aware in advance. This feature **will reduce the chance of cheating and of lost work**.

## Section 2: Selecting Online Alternatives to Common Assessment Methods (National Forum, 2020)

The National Forum in consultation with Teaching and Learning leads across higher education institutes compiled a list of alternative assessment methods and what to consider. A summary of the overall considerations is presented below and the complete guide is available <a href="here">here</a>. This is a very useful resource and worth reading. To support the rollout of this resource, GMIT T&L Office ran a series of clinics in April and October this year about alternative assessments and approaches to consider. #### Some key considerations:

- Before selecting an alternative assessment method for the online environment, please ensure you read the ten considerations for alternative assessments and the ten ways to make online assessment accessible and inclusive.
- It is important to **keep the assessments as familiar** as possible for students. There will be time to innovate in the future but, in the current context, the less complex and more familiar the assessment is, the better able students will be to adjust and succeed.
- In choosing alternative assessment methods, it is important to aim for the achievement of the same learning outcomes.
- With an alternative assessment, it may be that grading/marking criteria, rubrics or feedback procedures will need to be altered. It is crucial that you discuss any grading/marking changes with colleagues to ensure they are coherent and aligned. The detail of the revised grading/marking approaches should also be shared with students in advance of the assessment taking place.
- Before selecting an alternative assessment, familiarise yourself with any institutional directives/recommendations regarding, for example, selection of alternative assessments during COVID-19 or how students with limited/no internet access can be accommodated.
- Informed use of your institutional VLE will be crucial as assessment moves online. Be sure to familiarise yourself with your VLE and the options available to you and your students, such as how assessments can be recorded/stored, any file upload limits or what applications/software is supported by your institution.

#### Section 3: Promoting Students' Understanding of and Commitment to Academic Integrity

The following advice was adapted from T&L Office resources and the DCU guide to academic integrity, developed in April 2020, in response to the COVID emergency in assessing online. Recommendations are contextualised to GMIT online learning environment (Moodle).

Academic Integrity has been defined as a commitment, even in the face of adversity, to six fundamental values: honesty, trust, fairness, respect, responsibility, and courage. From these values flow principles of behaviour that enable academic communities to translate ideals to action (ICAI, 2014). Academic integrity focuses on positive student and staff behaviours, rather than the more negative behaviour that are emerging in higher education assessment practices, such as plagiarism and contract cheating. Education, prevention and detection have been identified as key to addressing, in particular, plagiarism.

Regardless of the alternative assessment that you chose, there are a few approaches to promoting a student's role and responsibility in this area:

- 1. **Educate students on what is meant by Academic Integrity**, be explicit about what this means within the context of your discipline and/or specific assessment task. Explain to students what is permitted and not permitted in relation to access to resources and other aid.
  - i. Tell students what sources, materials and people, they may and may not consult.
  - ii. Tell students how to cite those sources and refer students to the GMIT online training resources in the Student Hub.
  - iii. Tell students explicitly what kind of collaboration is permitted and what is not permitted.
  - iv. Communicate this to students in writing by email, on TEAMS and post the details in Moodle on the course page and on the programme page.
  - v. Require students to confirm agreement with an appropriate 'Academic Integrity Declaration' in Moodle.
- 2. Provide a sample 'Academic Integrity Declaration' set up that requires each student to sign off and submit. A sample is outlined as follows. A copy of the GMIT statement and instructions is available <a href="here">here</a>.

As a GMIT student, I declare that I have read and understand the following statements: I confirm that I did/will not give or receive any unauthorised help on this exam and that all work will be my own. I did/will complete this exam in a fair, honest, respectful, responsible, and trustworthy manner. I did/will adhere to the lecturer's instructions and I will neither give nor receive any assistance to others, other than what is permitted. The writing contained in this exam submission is my own, and any direct quotations have been identified and the reference cited. Additionally, I have cited references in any place where I have significantly borrowed someone else's ideas.

- 3. Provide students with instructions for the online exams and how to manage remotely. A sample guide is available here.
- 4. If students are working in teams/groups, have them create a Team Code of Ethics (so they'll hold each other accountable) (e.g. UC San Diego 2020 resource).
- 5. For an online quiz, an 'Academic Integrity Declaration' (see sample in point 2) could be presented as the first mandatory question in the quiz that the student must 'accept' before proceeding further.

- 6. Set up the 'safe browser' feature on Moodle (note this works best in the remote desktop lab environment).
- 7. For an assignment special project/open book exam, the student could be required to paste the text of the **Academic Integrity Declaration** and their acceptance of same into their assignment submission. The Academic Integrity Declaration text should be provided in the assignment instructions. (Note: this may affect the Urkund score if using Urkund but could be dismissed/allowed for when reviewing submissions).
- 8. Don't assume digital assessment is less secure. A useful guide in how to detect cheating can be reviewed at this link <a href="https://www.deakin.edu.au/">https://www.deakin.edu.au/</a> data/assets/pdf file/0003/2091567/07-cradle academic-integrity-online PM.pdf</a>. No assessment is immune to cheating. While in-person examinations are often thought of as more secure, recent large-scale survey research suggests that exams are the site of both more third-party cheating, and more undetected third-party cheating, than take-home written tasks (Harper, Bretag, & Rundle, 2020). The types of assignments students say they are least likely to cheat on are reflections on practicals, vivas, personalised and unique tasks, and in-class tasks (Bretag et al., 2019). Some of these are translatable into digital modes.
- 9. Conduct integrity checks (if required)
  - For smaller classes, you may follow-up with each student via MS Teams to talk through at least one of their answers. This is also known as 'academic integrity interview checks'. If the student can talk about it, and how they know what they know, this can indicate that they completed the online exam with integrity. Please ensure students are aware this may/or will take place after the online exam and schedule a time with the student for this interview check.
  - Use URKUND for any narrative exams and check all assignments (not just those with a certain percentage similarity).
  - If using the quiz function in Moodle for your exam, use their metrics and logs to check for signs of integrity violations. For example, you can see what time a student logged in and out, how long did it take them to finish (if marks appear quite high).
