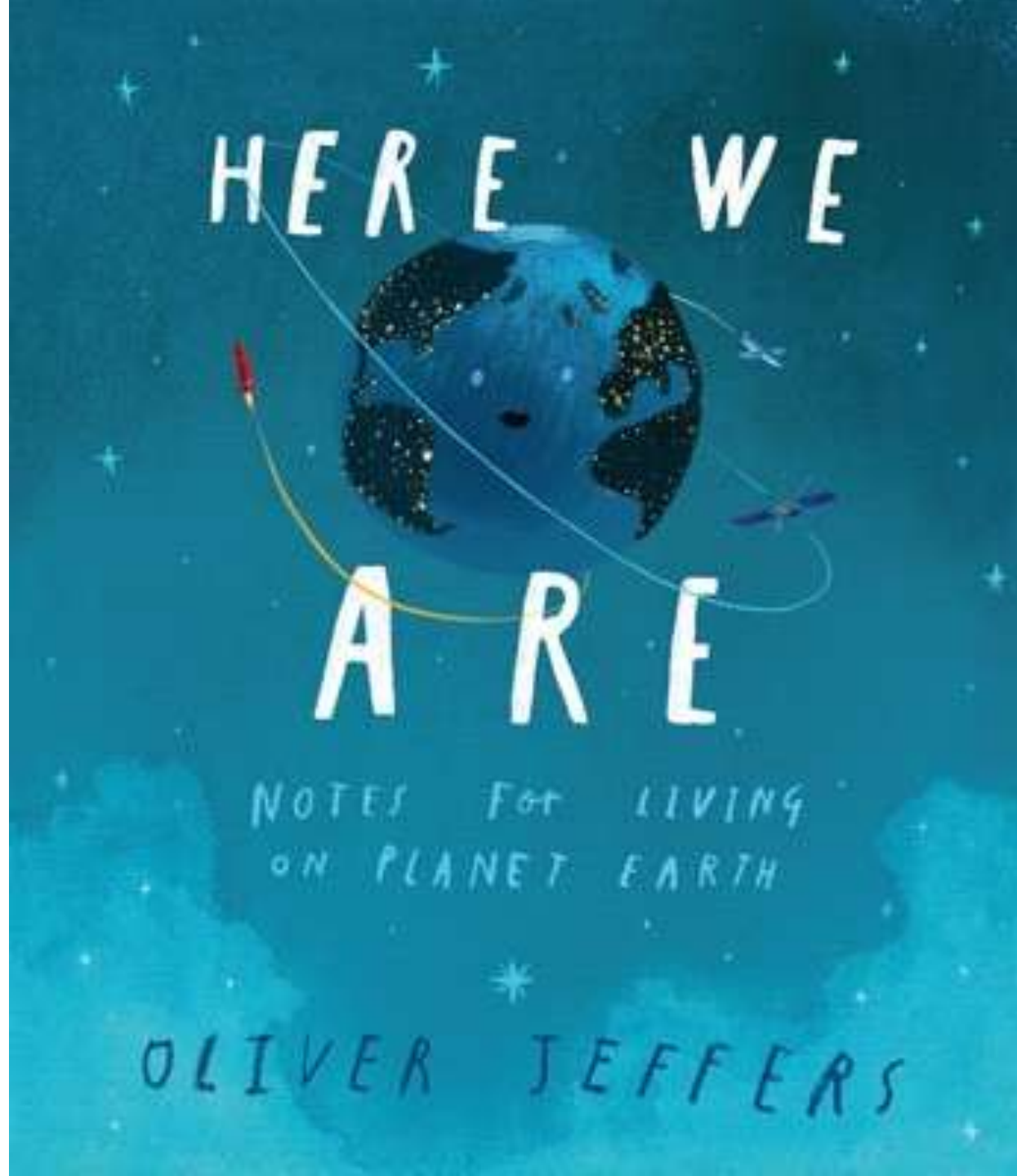

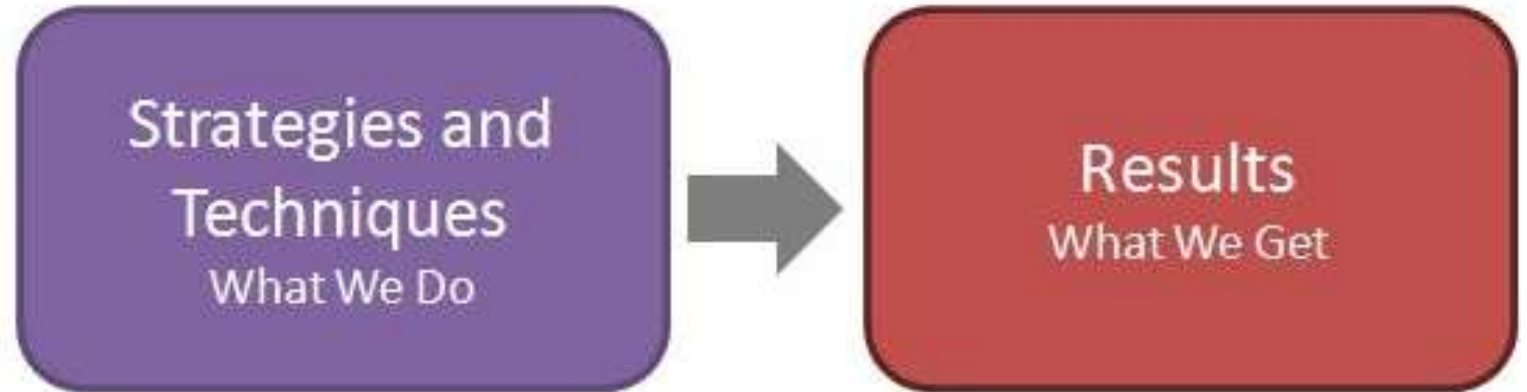


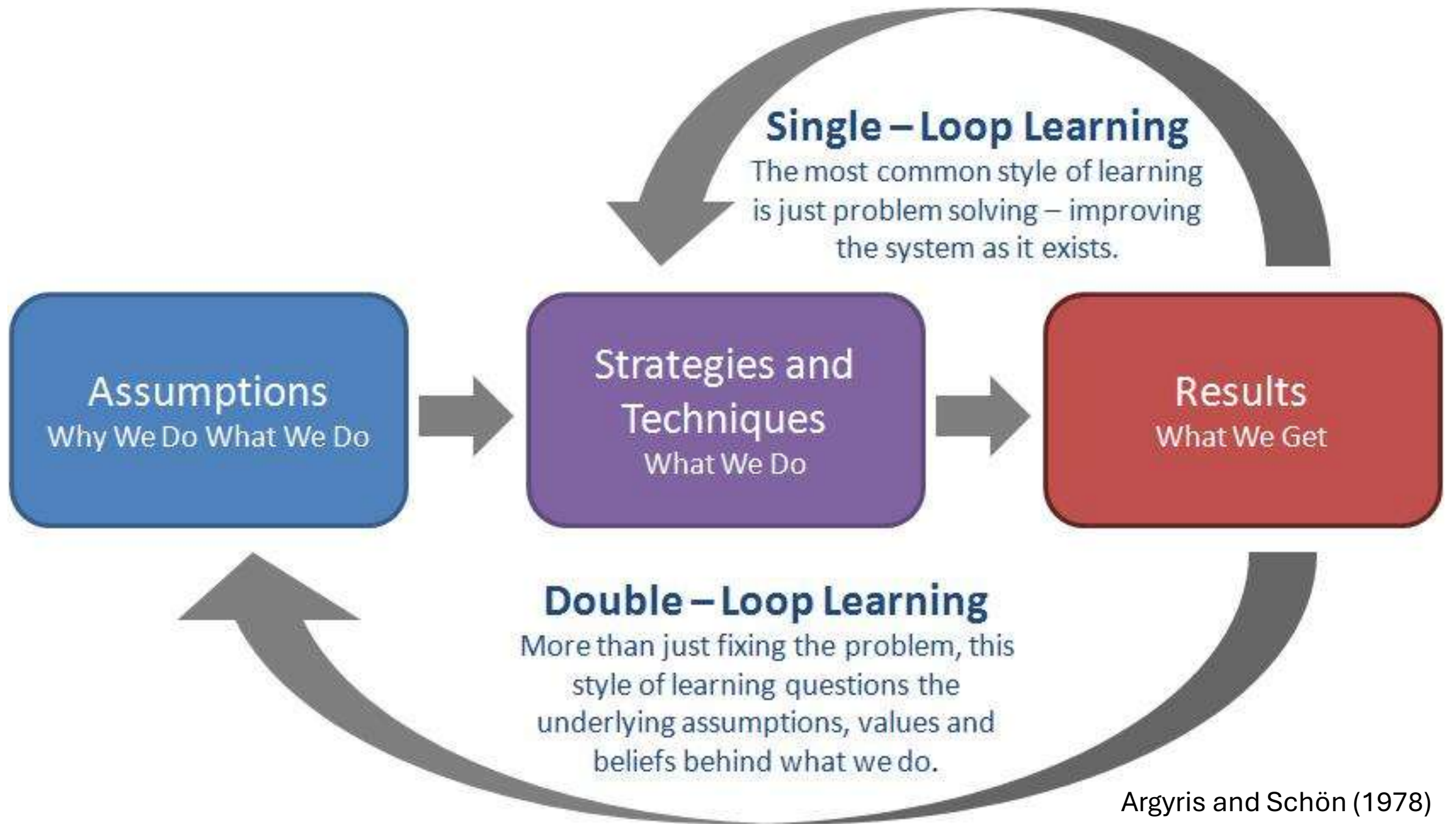
1. Our relationship to **knowledge** is changing
2. **Learning*** is becoming harder to measure

Single – Loop Learning

The most common style of learning is just problem solving – improving the system as it exists.

Ethos: An open & safe space for collaboration, engagement and professional development, non-hierarchical network.

Objective: position Scottish Tertiary Education as open, ethical and innovative in the use of GenAI in learning and teaching.

ScAITEN Activities



- **Sharing practice meetings**, with invited speakers
- **Open statement on principles** on the use of generative intelligence (GenAI) in learning and teaching
- **Outreach** to other sector bodies
- **Research** projects “Towards inclusive intelligence: a comprehensive examination of GenAI attitudes among HE stakeholders”
- Formalising network **governance** and structure
- **Expand** to include FE colleges in 2025
- Upcoming **training development** workshops in June 2026
- **Conference** in Autumn 2026

ScAITEN statement of principles on GenAI



Scottish Tertiary Education statement of principles on the use of generative artificial intelligence (GenAI) in learning and teaching

From 2023 to 2026, SCAITEN developed a high-level statement on use of generative AI in tertiary education, through extensive stakeholder consultation. The statement outlines an ethical, enhancement-led, and responsible approach to generative AI for the Scottish sector. It is structured around nine principles, each accompanied by related actions and aspirations. It serves as a foundation for institutions to guide discussions with students and staff, and to align with new or existing institutional guidance and position statements.

The Statement was intentionally written and openly licensed under Creative Commons as a living document, allowing it to evolve over time and be adapted for different contexts or areas of activity.

As a living document, it is intended to be regularly reviewed to reflect the evolving environment. It is intended that future versions may include or be repurposed for research, and relevant stakeholders are being liaised with to this end.

Developing the statement (1)

Key points from initial crowdsourcing across network

- Enhancement approach, social justice / common good, environment / sustainability and open educational practices
- Build upon Scottish Open Education Declaration, UN SDGs, Rusell Group Principles, and ALT's Ethical Framework for Learning Technology
- Statement should be openly licenced and available to others to reuse / remix (Wiley, n.d.).



Reflection: “Design by committee” (i.e. a large group) is tricky, so a smaller working group was helpful to create a coherent statement which curated all the contributions.



Developing the statement (2)

Timeline

- Initial whole-group meeting to identify topics and content.
- Smaller working group of network members to draft the statement.
- Full network asynchronous consultation & two further review meetings.
- Sectoral consultation

Reflection: Balancing further consultation in the sector, particularly with those who hadn't been party to the drafting conversations, was challenging, often repeated debates that had been resolved in the network.

The Nine Principles

- Human-centred
- Agency
- Trust
- Ethical
- Equitable
- Environmentally responsible
- Collaboration
- Openness
- Transparency



The intent of the statement is to inform and transform institutional and individual actions in relation to AI in learning, teaching and assessment, ensuring and embedding a social justice approach (Bali et al. 2020).

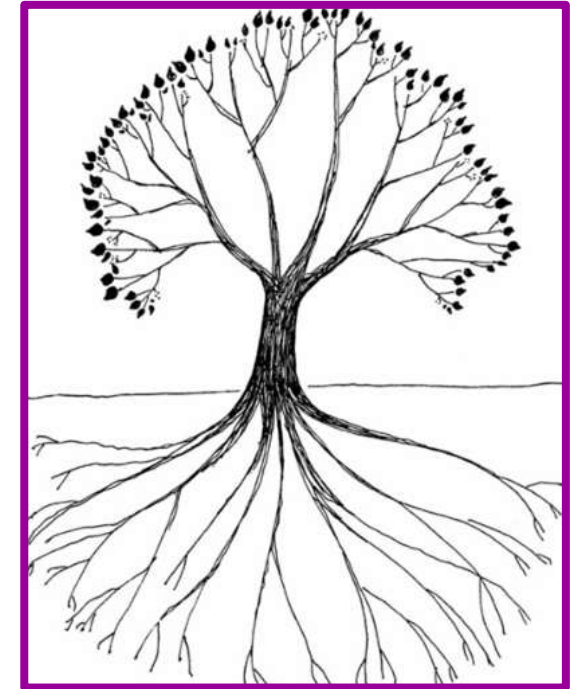
Where did the statement go next?

Sector buy-in

- Members to ask their institutions to ‘sign up’ to principles
- Engagement with Universities Scotland* Learning and Teaching Committee, supported by some Vice Principals for Learning and Teaching

Sector application

- Members use principles to inform policies and guidance
- Universities Scotland Learning and Teaching Committee endorsed statement
- Main US committee recommended a version created for whole sector for all areas of activity



*Universities Scotland is representative body for Scottish HEIs, similar to Irish Universities Association

Critical, compassionate and equitable approaches to GenAI

Critical discussions:

- Not just acceptance that GenAI is ubiquitous and inevitable (resistance).
- Encouraging critical thought about whether to engage and if so, how.
- Important to recognise it's not just AI, but all technologies that have environmental impact.
- GenAI is based on inequitable models but it can also help promote equity e.g. enhance accessibility for some people.



The value of openness

Openness essential to the development of the statement.

Licensed the statement under an open licence.

Value the input of open education practitioners and practices e.g Open Scotland Declaration, Open covid pledge.

Reflection: There was some education required within the network, and with senior management, as not everyone was familiar with open practices, particularly open licencing.

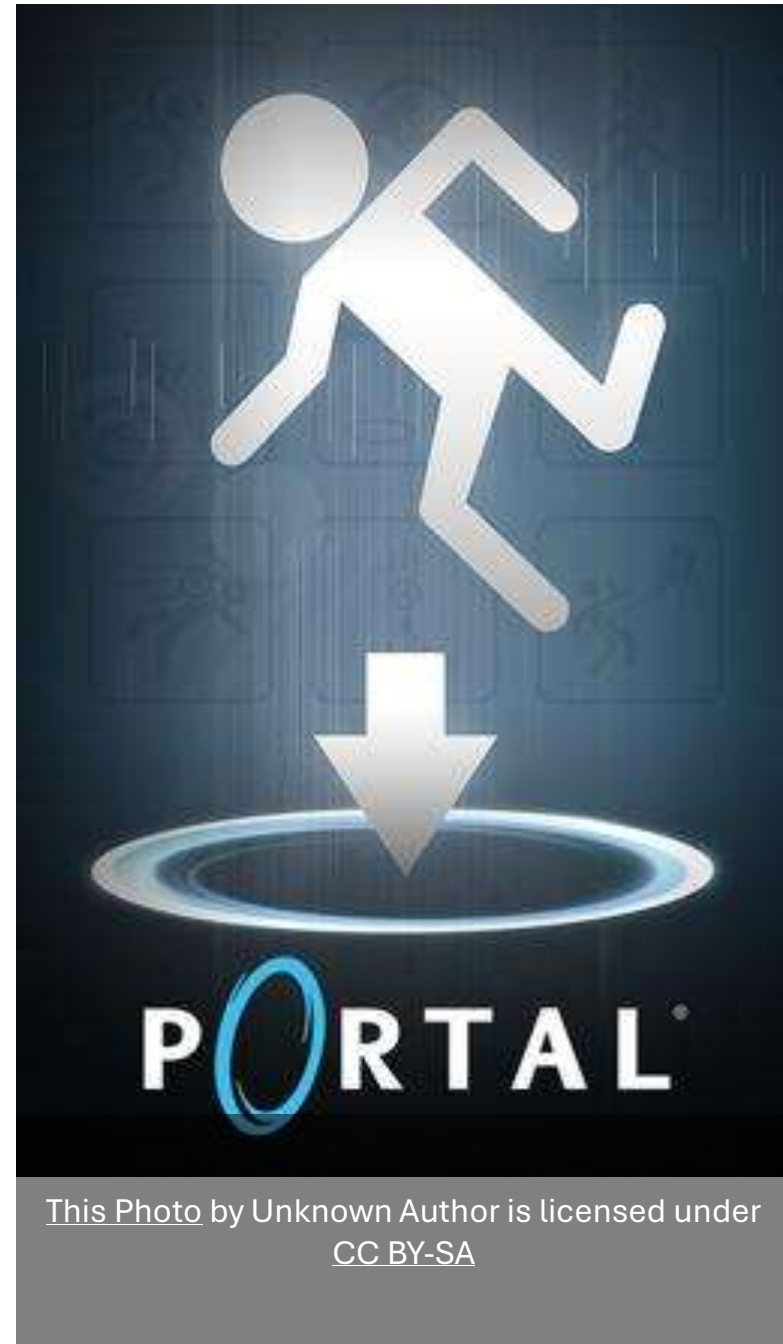


Some key findings

- Increasing polarisation of opinions
- Substantial proportion of students and staff report not knowingly using Gen AI
- Lack of environmental considerations key element in rejection of use
- Students are concerned about de-skilling
- The level of acceptable use by staff is decreasing
- Stigma around Gen AI use, leading to non-disclosure
- Demographic differences have nuanced relationships with Gen AI

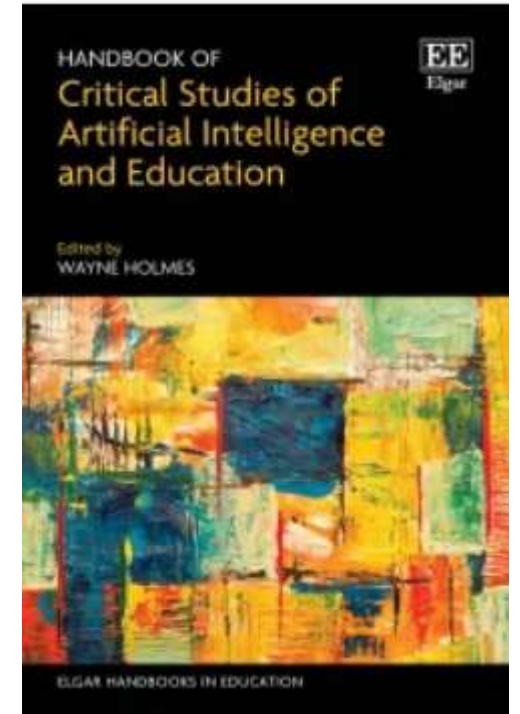

Critical Discourse Analysis of UK University Policies & Position Statements

- Gen AI as 'inevitable'
- Automatically 'enhancing learning'
- Invocation of authority through dominant norms and traditions
- Ambiguous who is responsible
- 'Both-sides-ism'

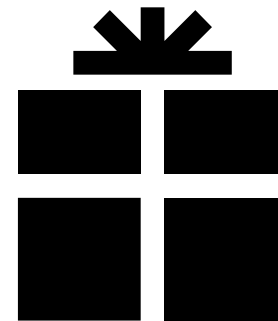

Open Letter: End the University of Edinburgh's Contract with OpenAI

Dear EDINA Leadership Team and those responsible for the University's contract with OpenAI,

We are publicly writing to you as the University of Edinburgh's contract with OpenAI is coming to an end, and we, as members of the university, wish to express our concerns and ask that the relationship with OpenAI does not continue.

The procurement of ChatGPT models from OpenAI conforms neither to the University's stated AI Principles, nor our Responsible Procurement Policy.

The [Responsible Procurement policy](#) states that our supply chains should: "Have targets and action plans in place to reduce their carbon emissions" and "provide carbon emission reporting.", "commit to Fair Work practices" and "align to the University's human rights related policies". Using OpenAI as a supplier is contrary to these commitments.

OpenAI's models, as proprietary and closely guarded secrets, necessarily run on OpenAI's hardware, which makes it impossible to monitor the energy usage due to ELM. ([OpenAI environmental impact disclosures are opaque](#), but we do know that [data centres have massive climate footprints](#).)

Influential study touting ChatGPT in education retracted over red flags

The retracted study on ChatGPT in education was already cited hundreds of times.

A study that claimed OpenAI's ChatGPT can positively impact student learning has been retracted nearly one year after publication. The journal publisher, Springer Nature, cited “discrepancies” in the analysis and a lack of confidence in the conclusions—but not before the paper racked up hundreds of citations and made the rounds on social media.

(Robust) Evidence

Open questions...

- How can we work collaboratively, when we know we don't all agree about Gen AI?
- How can we encourage transparency and openness, when there is stigma attached to it?
